The Disciplinary Committee investigated the Erste Liga game EL 89 (DVTK Jegesmedvék – FEHA19) incidents following the end of the game. After the end of the game, fights and scuffles broke out, during which the referees imposed the following penalties:

#### DVTK

#63 Doyle Colin Fredrick – 5+20 minutes Game Misconduct penalty for Roughing,  
#21 Pineo Jason Clarke – 5+20 minutes Game Misconduct penalty for Roughing,  
#74 Hunt Garet Joseph – 5+20 minutes Game Misconduct penalty for Roughing.

#### FEHA19

#61 Bogestic Vedran – 5+20 minutes Game Misconduct penalty for Roughing,  
#21 Falus Ádám – 5+20 perc minutes Game Misconduct penalty for Roughing.

According to the Erste Liga Competition Rules, players who are subject to a Game Misconduct penalty will receive an automatic 1-game suspension, regardless of the decision of the Disciplinary Committee.

*Erste Liga Competition Regulations 71/a. § - If a player receives a Game Misconduct Penalty within the last 5 minutes of the regular playing time of the given game, or at any time during the extra time, he will automatically be suspend for one game.*

Regarding the incidents, the Committee made the following conclusions:

Doyle Colin Fredrick (DVTK Jegesmedvék) at the end of the game, holding his stick with both hands, struck his opponent with great force, and then got into a fight with his opponent. His action was the focal point of the subsequent crowd scene.



**The Disciplinary Committee has suspended Doyle Colin Fredrick, the DVTK Jegesmedvék player, for 1 additional Erste Liga game, in addition to the automatic 1-game suspension.**

Pineo Jason Clarke (DVTK Jegesmedvék) pulled, hit, and started a fight with his opponent.

**The Disciplinary Committee upholds the penalty imposed by the referees on the game against Pineo Jason Clarke and will not impose any further sanctions in addition to the automatic 1-game suspension.**

Hunt Gareth Joseph (DVTK Jegesmedvék) initiated a fight against his passive opponent, causing him injury. He did not leave the ice despite repeated requests from the referees, he acted as an aggressor, and later intervened in an already existing fight.

**The Disciplinary Committee has suspended Hunt Gareth Joseph, the DVTK Jegesmedvék player, for 2 Erste Liga games in addition to the automatic 1-game suspension.**

Vokla Roland was the umpteenth person to intervene in an already-escalating brawl, hitting his opponent several times.

**The Disciplinary Committee has suspended Vokla Roland, the player for DVTK Jegesmedvék, from 1 Erste Liga game.**

Bogestic Vedran (FEHA19) grabbed and pulled his opponent and released him at the referees' request.

**The Disciplinary Committee upholds the penalty imposed by the referees on the game against Bogestic Vedran and will not impose any further sanctions in addition to the automatic 1-game suspension.**

Falus Ádám (FEHA19) got into a brawl with his opponent.

**The Disciplinary Committee does not apply any further sanctions in addition to the automatic 1-game suspension to Falus Ádám.**

According to the Erste Liga Competition Rules 72/B. § (1) the prohibition imposed an automatic fine on the DVTK Jegesmedvék. The organization must pay according to 72/B. § (2):

400 EUR - Doyle Colin Fredrick regarding the suspension,

150 EUR - Pineo Jason Clarke regarding the suspension,

800 EUR - Hunt Gareth Joseph regarding the suspension,

150 EUR - Vokla Rolnad regarding the suspension.



According to the Erste Liga Competition Rules 72/B. § (1) the prohibition imposed an automatic fine on the FEHA19. The organization must pay according to the 72/B. § (2):

150 EUR - Bogesic Vedran regarding the suspension.

150 EUR - Falus Ádám regarding the suspension.

The players will spend down his suspensions at the next Erste Liga, and Hungarian Cup games.

**During the suspension, the maximum total points value of the team's players eligible for the match will be reduced by the points value of the suspended player or players. Only after the suspension or suspensions have expired will it reach the maximum set in the competition schedule again.**
